Sample Communication Templates for Floods

As you adapt flood templates for use in your city or county, keep these best practices in mind





FEMA calls flooding the most common natural disaster in the U.S., destroying homes and claiming dozens of lives each year. It doesn't take much. As little as one inch of floodwater can cause \$25,000 in property damage. Just six inches can send a river spinning out of control.

Time is of the essence when it comes to flood alerts. That's why we created the **SMS text and email templates** below. Use them as guides for your own communications efforts via OnSolve[®] CodeRED[®]. While we can't create content that addresses your community's specific needs, we can help you feel confident about getting the word out, particularly to those who face logistical challenges due to the pandemic.

Three best practices to keep in mind

- O1 Strive for clear, concise language, and don't underestimate your audience's attention span. Now, more than ever, the public wants details and will take action when you provide them.
- **O2** Set the "stage" by including these essential elements in all critical event communications:
 - Source State who's sending the alert*
 - Threat Describe the potential danger to people and/or property
 - Area Describe the impact area using street names, landmarks and boundaries
 - Guidance Tell your audience what, when and how to take action
 - Expiration Let your audience know when the alert expires
- O3 Practice using your templates throughout the year. The best way to know how your communication plan is working is to test it. If there are gaps or areas for improvement, testing will highlight them and help you strengthen your alerts.

*Note: We recommend emails go out under a government official's signature.

Six tips for using message templates

- 01 Does your communications strategy include voicemail? Feel free to adapt our text examples to voice alerts.
- Every situation is different. Use all caps to highlight key information and modify the templated [ALL CAPS IN BRACKETS] to suit your situation.
- O3 Stick to one topic. You may have cases that call for more than one, like messages telling residents it's safe to return home and instructing them on how to report damage. But generally speaking, single-topic messages improve readability.
- 04 Include links or community bulletin board numbers for additional information. Encourage community members to <u>visit FEMA</u> to learn about their flood zone designation.
- O5 Check character count limits for your delivery channels. Twitter, SMS text and the Integrated Public Alert and Warning System (IPAWS) all have different allowable character counts. Know their limitations before you send critical alerts.
- O6 Know your recipients' expectations. Does your community expect short, frequent updates or longer details in a single pass? Include a feedback option in your routine testing to gather insights on local delivery channels.

Communications before a flood

Before a major flood, focus on precautionary alerts, reminders and restrictions. Remember, the more you share, the more likely you can save lives.



SMS Examples

The National Weather Service has issued a coastal flood alert for [COUNTY NAME] County until [DATE]. Take precautions on beaches and stay tuned for updates. More info at [WEBSITE]. Alert expires [DATE].

Flash Flood Alert. Use extreme caution and follow posted speed limits on roads. Just six inches of water can cause serious hydroplaning. Stay tuned for updates. More info at [WEBSITE]. Alert expires [DATE].

Dam Breach Threat Level I in this area until [DATE/TIME]. Check and monitor local media for updates.

Keep family and pets safe and prepare to move to higher ground or evacuate if necessary.

Review a communication plan in the event of a power outage. Alert expires [TIME].

Tidal Surge Advisory. Fast-moving waves of at least 10 feet are predicted to reach [CITY] by [TIME]. Follow directions from state and local officials and prepare to evacuate if necessary. More info: [WEBSITE]

Communications during a flood

Alerts sent during a flood include evacuation and road closure information, shelter information, utility outages and other critical flood alerts. Remember, the more you share, the more lives you'll save.



SMS Examples

[ROAD NAME] at [LOCATION] is closed due to rising river levels. Stay off bridges over fastmoving water and follow detour signs at [ROAD NAME] and [ROAD NAME]. Notice expires [DATE].

CRITICAL FLOOD UPDATE: Evacuation orders are in effect in [LOCATION]. DO NOT attempt to enter evacuated areas at this time. Please cooperate with local authorities and first responders.

EVACUATE NOW! MANDATORY evacuations for [LOCATION] due to flooding at [LOCATION]. Please relocate immediately to evacuation shelter at [SHELTER ADDRESS]. More info: [WEBSITE]

MAJOR FLOOD DAMAGE at [LOCATION]. Crews currently on site. Please stay clear of area. More info to follow. [WEBSITE]

Communications after a flood

Your post-flood alerts should include instructions for returning home and reporting damage, as well as utility restoration guidance and other directives. Provide as much detail as possible, while keeping alerts brief. Remember, the more you share, the more lives you'll save.



SMS Examples

Governor [LAST NAME (OR OTHER PUBLIC OFFICIAL)] has declared that residents and businesses may return to [LOCATION] area. Documentation of residency will be required. [WEBSITE ADDRESS]

Residents and businesses are now allowed to return to their homes or workplaces with proper documentation. Unauthorized visitors must stay away from the area. Please cooperate with first responders. [WEBSITE ADDRESS]

For residents returning to the [LOCATION] area, please report damage or threats to structures, roadways and utilities. [REPORTING INSTRUCTIONS]. Please submit reports at [WEBSITE ADDRESS].

For residents returning to [LOCATION] area: [POWER COMPANY NAME] estimates power restoration on [DATE]. [WEBSITE ADDRESS]
